IBP AT 50:

CONTINUING THE LEGACY OF TOUCHING LIVES

AND MAKING A DIFFERENCE

Hosted by the IBP Southern Luzon Region at the Podium Hall in Mandaluyong City on October 27, 2023, the Integrated Bar of the Philippines (IBP) successfully conducted the second leg of the Code of Professional Responsibility and Accountability (CPRA) rollout, a key component of the Supreme Court's Strategic Plan for Judicial Innovations 2022–2027 (SPJI).



The CPRA Rollout, part of the IBP's support for the Supreme Court's information campaign, featured discussions by deputy directors and commissioners of the IBP Commission for Bar Discipline on the new provisions of the CPRA, including notarial practice. With the first leg held in Cotabato last September, and 15 more legs planned until 2025, the IBP encourages all lawyers to familiarize themselves with the updated code, emphasizing its role in elevating the standards of the legal profession. The third leg is scheduled for December 2023 in Cebu.



IBP AND JFBA COLLABORATE IN 2023 PHILIPPINES-JAPAN LAW CONFERENCE




ON MARRIAGE DISSOLUTION AND INHERITANCE

he Integrated Bar of the Philippines (IBP), the Japan Federation of Bar Association (JFBA), and the UP College of Law ASEAN Law Program organized the 2023 Philippines–Japan Law Conference to deep dive into Philippines and Japan laws on marriage dissolution and inheritance. The conference was conducted on November 17, 2023, at the University of the Philippines College of Law, Bonifacio Global City Campus.

In the opening panel, Atty. Seiji Yamamura discussed Japanese divorce law while Atty. Takayuki Obata delved into the details of Japanese divorce by agreement procedures.











Keynote Speaker Associate Justice Angelene Mary W. Quimpo-Sale shared insights on Philippine law, focusing on the procedural intricacies involved in the recognition of Japanese divorces.


Prof. Elizabeth Aguiling-Pangalangan navigated through the legal implications of foreign divorces in the Philippines, while UP ASEAN Law Director Andre C. Palacios provided a comprehensive discussion of Philippine judicial notice of foreign laws in relation to marriage and divorce.



For the afternoon session, the audience was treated to an in-depth analysis of inheritance laws spearheaded by Professor Marie Cecile Roque-Quintos, Atty. Keiko Sugawa, and Atty. Kaori Okubo.



This timely and opportune event aimed provide to context to Family Law practitioners, and harmonize the differing legal frameworks of Philippines and Japan. As legal minds from both nations their shared expertise, the conference marked a pivotal moment in promoting legal cooperation and understanding between the lawyers of the two countries.



he UP Institute for the Administration of Justice (UP IAJ) organized a forum to take a closer look into a study by Dr. Björn Dressel and Cristina Regina Bonoan, entitled "Justices and Political Loyalties: An Empirical Investigation of the Supreme Court of the Philippines, 1987–2020." Held at the UP College of Law on October 25, 2023, the forum featured intellectual heavyweights as panelists, namely, former International Criminal Court Judge Raul C. Pangalangan, UP School of Economics Professor Emeritus Solita C. Monsod, Professor Dante B. Gatmaytan, and Professor Gwen Grecia-De Vera.

The study aimed to unravel the determinants of Supreme Court behavior within the broader democratic landscape of the Philippines.

UP LAW FORUM DELVES INTO SUPREME COURT JUDICIAL ALLEGIANCES




Notably, Atty. Bonoan clarified that the study was descriptive and predictive, emphasizing correlation rather than causation.

Dr. Dressel acknowledged the Judicial Bar and Council's efforts to enhance transparency in the appointment process, clarifying that the study does not conclude corruption but identifies a dynamic tension causing external pressure on justices. In the same vein, Atty. Bonoan stressed that the study emphasized correlation, rather than causation. The forum provided a platform for insightful discussions which shed light on the complexities of judicial behavior and its implications on the Philippine justice system.

FEATURED RESOLUTION

SUPREME COURT
APPROVES RULES ON
ANTI-TERRORISM



n an En Banc Resolution dated December 5, 2023, the Supreme Court approved A.M. No. 22-02-19-SC or the "Rules on the "Rules on the Anti-Terrorism Act of 2020 and Related Laws" (the Rules). The *ad hoc* Committee tasked with drafting the Rules was led by the venerable Chief Justice (Ret.) Reynato S. Puno and Associate Justice Rosmari D. Carandang.

The Rules set the procedure for issuing an Order of Proscription declaring as terrorist any group of persons, organization or association that commits acts of terrorism defined under the law.

Under the Rules, law enforcement agents or military personnel are required to secure a written Authorization for Surveillance from the Court of Appeals before they can secretly wiretap, overhear, listen, intercept, screen, read, surveil, record or collect any private communications, conversation, discussion, data or information between subjects or targets of Surveillance Orders.

Notably, the Rules expressly prohibit written orders for the surveillance of communications between: a)lawyers and clients; b) doctors and patients; c) journalists and their sources; and d) confidential business correspondence.

he IBP – Rizal, San Juan Mandaluyong (IBP-RSM) successfully hosted a block screening at Robinson's Magnolia VIP Cinemas of "The Hunger Games: A Ballad of Songbirds and Snakes," last November 19, 2023. 

Despite commendable efforts by the Bureau of Jail Management and Penology (BJMP) in reducing congestion rates, recent findings from the Commission on Audit (COA) reveal that a substantial number of jails still face overcrowding.

In 2022, 67% of the country's jails were congested, with occupancy rates reaching a staggering 2,739%. Although the BJMP has made progress, reducing congestion rates by 358%, as of July 15, 2023, 329 out of 479 jail facilities
