Advanced Course in Commercial Arbitration IBP and PIARB Dual Accreditation Course

1-2 December 2016 (Seminar) | 8 December 2016 (Examination)
JBL Hall, 4/F IBP Building Doña Julia Vargas Avenue,
Ortigas Center, Pasig City

This 2-day course provides participants an in-depth training in commercial arbitration and aims to supplement their basic knowledge of the principles, procedures and best practices in arbitration. The course will include, but will not be limited to, lectures on arbitration-related topics. While the course does not require prior experience or training in arbitration, the participants will be provided with pre-course materials and will be expected to have reviewed the materials prior to the start of the course. Break-out sessions may be conducted by the speakers/facilitators to test the participants' familiarity with the materials and understanding of the principles of arbitration.

Those who complete the course will have the option of taking an examination for the purpose of assessing their understanding of commercial arbitration which will give them the opportunity to: (a) qualify for admission as Member** of PI Arb (allowing them to use the post-nominal "MPI Arb"); and (b) to be included in the list of IBP-trained arbitrators.

* The 2-day course is open to those who attended previous IBP arbitration seminars or other basic arbitration seminars, Associates in PI Arb, arbitration practitioners who wish to become "Members" of PI Arb or be included in the IBP list of trained arbitrators

**PI Arb has 3 regular membership categories, with Associate (API Arb) status being the normal entry grade. Passing the proficiency exam of this course will allow participants to be admitted as full Members (MPI Arb), which is generally a prerequisite to election as a Fellow (FPI Arb) of the Institute
